

2025 TTA Equipment and Facilities Grant Program Application

Participation is a key strategic pillar in Table Tennis Australia's (TTA) Strategic Plan, as we seek to connect all Australians with table tennis. A key outcome of the plan is to support clubs to access appropriate facilities.

TTA's Equipment & Facilities Grant Program provides an opportunity for grassroots table tennis clubs & associations across Australia to purchase new equipment; or assist with the upgrade/improvement of local table tennis facilities.

A maximum facility funding of \$4,000 or up to \$2,000 for equipment is available for a limited number of eligible affiliated table tennis clubs & associations every year. TTA will consider funding up to a <u>maximum of 50%</u> of the project's total value (within funding category limits). However, applicants should <u>only</u> apply for the amount needed.

Quote(s) for all relevant equipment and/or facility costs must be provided with your application.

- Project receipts & photos of your new equipment and/or facilities will be required for your acquittal.
- Funding will **not** be approved for retrospective purchases (e.g. grants **cannot** be used to refund purchases)
- The first 50% of the grant will be disbursed at the start of the project, and the balance will be disbursed upon submission of the acquittal report.
